

Introduction to Building Fireproofing Products

#### WREN'S WESTERN OUTPUT



To reduce the risk of bad project outcomes, reduce the overall project time. The author suggests, "making haste slowly". Think slowly at first, then build fast. While this may be expensive in the design phase with a large team of architects and engineers, it's surely less costly than encountering delays during construction that would have been avoided had more time and effort been expended up front. As Abe Lincoln said, if I had five minutes to chop down a tree, I'd spend the first three minutes sharpening my axe.

A comparison of Gehry's Bilbao Museum with the Sydney Opera House illustrates what can happen without enough time spent up front. Jorn Utzon's entry for the Sydney Opera House won the design competition but without any detailed designs or cost estimates. The cost presented to the public by the owner, the Australian government, was low balled. It was rushed into construction in 1959 to meet an arbitrary start date set by the prime minister. So construction began without final construction documents having been completed. As a result some of the new construction had to be demolished as the final details were developed. Utzon fled the country in disgrace, the project was finished without his input and was initially an acoustical and functional disaster. It was 1,400% over the initial budget and its initial construction schedule expanded from 5 years to 14 years.

Gehry's project at Bilbao was exactly the opposite. Gehry's design process moved steadily from sketches to models. On Bilbao he spent 2 years on massing models. Using CATIA software, he translated the curves in his physical models into 3D-drawing models. Problems that arose, as they always do, were solved in the least-cost way possible by using an iterative process early in the design, before CDs, and before construction.

The Sydney Opera House is also an example of the effect of political influence on a project. Project budgets and schedules are often established based on what's politically acceptable, not based on the facts of the project. "What's most important is what will sell it to the public." Willie Brown the former mayor of San Francisco and speaker of the California State Assembly, made this remark regarding public projects. The advertised budget is just a down payment. If the public knew what a project was really going to cost, they would never approve it in the first place. This is called strategic misrepresentation. Governor Jerry Brown apparently knew this when he was promoting the CHSR project.

Once a project has been approved, the next step is to get busy with the work so that it quickly progresses to the point where it won't be stopped once the real cost becomes apparent. This is called the "commitment fallacy" by psychologists and is often followed by the "lock-in" or "escalation of commitment" fallacy so the project won't be abandoned. Commitment fallacy results from the "sunk cost fallacy" meaning that people are focused on the cost already sunk in the project rather than making a decision on proceeding, or not, based on the costs of continuing. Politicians know the public doesn't like to see a project abandoned because they would then lose their sunk costs, so projects often continue when an objective analysis suggests it be abandoned. (See California Governor Newsom's decisions to continue with the CHSR project after he became governor.)




